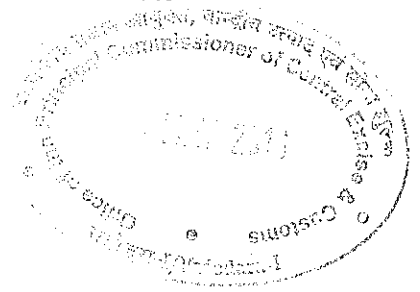





The Directorate General of Central Excise Intelligence, Delhi Zonal Unit is in the process of drawing of a panel of willing and suitable officers for filling up the vacancies in the grade of Intelligence Officer on deputation basis in its Zonal Unit at Delhi and the Regional Units at Jaipur, Rohtak, Ludhiana.

It is proposed to fill up these vacancies by appointing suitable officers from the grade of Inspector of Customs & Central Excise. The officers who have been granted financial up gradation under the MACP Scheme, are also eligible for the said posts.



The selected officers, while working in the Directorate General in the grade of Intelligence Officer on deputation basis, will be entitled to admissible deputation allowance. Normally, the deputation is for 5 years, which is extendable by another two years, subject to the willingness of officer, his/her performance, concurrence of his parent Commissionsonerate and the approval of the competent authority.

It is requested that this circular may please be brought to the notice of all the formations under your jurisdiction and the applications of willing officers be forwarded to the Additional Director General, DGCEI, Delhi Zonal Unit, at the above mentioned address. While forwarding the names of the willing officers, the following information may also be sent for evaluation by the Directorate General:

1. Complete bio-data and willingness of the officer along with history of previous postings;
2. ACR/APAR grading for the last 5 years (duly verified and attested by the Addl./Joint Commissioner (P&V);
3. Vigilance Clearance; and
4. No Objection Certificate from the Cadre Controlling authority to relieve the officer in the event of his/her selection.

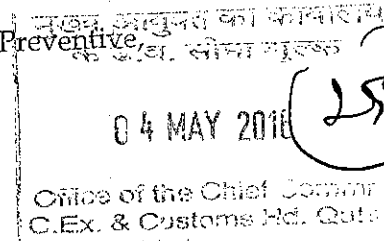


Options are invited to fill up the following vacant posts on deputation basis in the Directorate General of Systems at Delhi office:

2. These post will be filled up on deputation basis from amongst the officers of the similar ranks working in the formation of Customs, Central Excise and Service Tax and officers holding analogous posts in the Directorate General/ Directorates under CBEC in the same pay scale. The age of the officer shall not exceed 56 years as on closing date of this circular.
3. Such officers selected for a posting in the Directorate General of Systems at Delhi, would normally be appointed for a period of 3 years but extendable upto 5 years.
4. It is requested that applications of the interested and eligible officers may be forwarded to this Directorate General with their particulars viz, name, address, educational qualification, date of birth, History of Posting, present post and the date from which it is held, scale of pay, experience alongwith synopsis of their ACR Gradings, for the last five years and also "No objection Certificate" from the concerned Commissionerate/Director General/Directorate within 90 days from the issue of the circular. It may also be thought to the notice of the willing officers that once they are selected, they will not be allowed to withdraw their candidature and also will not be relieved till the expiry of the tenure of three years. It may also be certified that no vigilance case is pending or being contemplated against any such officer.

5. In case, while working in this Directorate General, the work and conduct of the officer is not found to be satisfactory, the officer can be reverted to the parent Commissionerate/Directorate before completion of the deputation period
6. Selected officers will have to make their own arrangement for residential accommodation.
7. Selected officers will be entitled for deputation allowance as per rules.
