Subject : Preparation of a panel for filling up the post of Stenographer Grade -I, Group 'B' (Non-Gazetted) on deputation basis in the Directorate of Publicity & Public Relations, Customs & Central Excise, New Delhi - regarding.

It is proposed to draw a panel of suitable and eligible officers for filling up the deputation post in the grade of Stenographer Grade -I, Group 'B' (Non-Gazetted) in the Directorate of Publicity & Public Relations, Customs & Central Excise, New Delhi on deputation basis. At present there are 2 vacancies in the grade of Stenographer Grade -I, Group 'B' (Non-Gazetted) in the Directorate at New Delhi to be filled up through deputation. The posts are in the PB-2/Rs.9300-34800 with a grade pay of Rs.4200.

2. In accordance with the Recruitment Rules, applicable to the post, the officials holding the following posts on regular basis are eligible to be considered for appointment against the deputation post of Stenographer Grade -I, Group 'B' (Non-Gazetted) in the Directorate.

Officers holding the post of Stenographer under the Central Government

- (i) holding analogous post on regular basis in the parent cadre or department ;
or
(ii) with three years regular service in the Pay Band I with Grade Pay of Rs. 2400 or equivalent

ESTT **Note 1:** The departmental officers in the feeder category who are in the Direct line of promotion shall not be eligible for consideration for appointment by deputation. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: Period of deputation including the period of deputation in another ex-Cadre post held immediately preceding this appointment in the same or some Other Organisation or department of the Central Government shall ordinarily Not Exceed three years.

The Maximum age limit for appointment by deputation shall be 'Not exceeding 56 years' as on the closing date of receipt of applications.


Note 3 : For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1st January, 2006 (the date from which the revised pay structure based on the Sixth Central Pay Commission recommendation has been extended) shall be deemed to Be Service Rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Pay commission except where there has been merger of pay into one pre-revised scale of pay into one grade with a common grade pay or pay scale and where this benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any upgradation.

3. The officials selected for postings as Stenographer Grade -I, Group 'B' (Non-Gazetted) in this Directorate on deputation basis would be appointed initially for a period of 3 years. The pay of the selected officer will be regulated in accordance with the Ministry of Finance O.M. No. 19(24) E III/60 dated 04.05.1991 as amended from time to time.

4. Application from interested and eligible officer accompanied by relevant personal data with - name, date of birth, education, qualification, knowledge of operating computers if any, present post and the date from which it is held, scale of pay, history of previous postings along with charges held accompanied by their CCR dossiers may please be forwarded to this Directorate latest by 14/ 3/2016. It may also please be certified that no vigilance/non-vigilance case is pending or being contemplated against any such officers. Preference will be given to officers who have knowledge of computer application. Officers applying for the post may be clearly made to understand that once they apply for the post, they will not be allowed to withdraw their candidature subsequently.

5. It is requested that this letter may be widely circulated amongst the eligible officers under your jurisdiction.
