ANNEXURE-B

Terms & Conditions

- 1. The department will provide Canteen Hall, furniture, electricity & water.
- 2. The Canteen Contract is for the period of one year starting from 01.04.2014 to 31.03.2015.
- 3. The Canteen Contract may be renewed for the further period as deemed fit by the department.
- 4. The Contractor will have to give **security deposit** amount of Rs.50,000/- (Rupees Fifty Thousands only), refundable after adjusting the cost of damage/loss, if any, done to the Canteen during the tenure.
- 5. The Contractor will have to provide hygienic food and good quality tea, coffee, milk, etc., to the staff/officers at the rates quoted by them.
- 6. The Contractor will have to serve tea, coffee and other items to the Officers in their Chamber.
- 7. The Contractor will have to bring their own utensils, fuel and other equipments required for cooking and serving in the Office Canteen.
- 8. Department shall not be responsible for any loss or damage done to the Canteen and the Canteen Contractor shall bear the entire loss or damage.
- 9. The Contractor will have to maintain the Canteen neat and clean.
- 10. The Canteen will be supervised by the nominated Officer/s. The nominated Officer will test the hygienity of the food to be supplied from the Canteen for a particular day.
- 11. The Contract can be cancelled at any time without prior notice and assigning any reason.
- 12. In case if the contractor wishes to terminate the contract, he/they shall intimate the same to the department by giving one month notice stating the reasons thereof.
- 14. Tenders filled in pencil, overwriting, illegible or erased will not be considered.
- 15. Each page of the bid/tender document should be signed by the bidder(s). Incomplete or un-signed quotations are liable to be rejected.
- 16. Tenders will be opened on 18.03.2014 at 15.30 Hrs. The interested bidder or his/her authorized representative can participate in it. In case 18.03.2014 is a closed holiday, the tenders/bids shall be opened on following working day at the same time and venue.
- 17. All relevant rules and regulations of Government of India will be final and applicable & binding on all bidders.
- 18. If any disagreement or dispute arises between the bidder and the department under any circumstances or in connection with the terms & conditions, they shall make every effort to resolve the matter amicably by direct informal negotiation. Even then, if any disagreement arises, the same shall be settled under the Court of Law within the jurisdiction of Vadodara.
