Attention of the Trade is invited to this Commissionerate's Trade Notice No.02/2008 dated 05.02.2008 constituting the Regional Advisory Committee.

The term of the Regional Advisory Committee for organized sector, Service Tax Sector and Public Grievance Committee is expired on 31.12.2009. As such a new committee will be constituted for the block years 2010 and 2011 with effect from 01.01.2010.

The Composition of the Regional Advisory Committee will be as under:

*They should represent the manufacturers of important commodities and not merely different excisable commodities produced in the Commissionerate.

The Additional Commissioner (Tech) of Central Excise & Customs, Vadodara-I will be the Secretary of the Committee.

The function of the Combined Regional Advisory Committee will be purely advisory. It will strive to resolve procedural

difficulties of general nature. It may however, discuss in a general manner any matter including the policy behind the individual cases but excluding individual cases themselves and judicial and quasi judicial matters.

The Committee will normally meet once a quarter on such dates as the Chairman may decide. The meeting will ordinarily be held at the Commissionerate Headquarters.


The Committee will be constituted for a period of two years 2006 & 2007 and accordingly the terms of the office of each member nominated in the committee will normally be for two calendar years.

Since every Commissionerate of Central Excise has its own Regional Advisory Committee, the points raised for discussion should as far as possible, relate to the matter pertaining to the units in the jurisdiction of Central Excise Commissionerate, Vadodara-I.

Traveling allowance and Daily allowance admissible to members of the Committee, will be regulated in accordance with the existing rules/instructions.

All Trade Associations, including Associations of major producers of excisable commodities i.e. (1) Association of Engineering Industries, (2) All India Manufacturers Organizations, (3) All India Exporters Associations, (4) Chambers of Commerce & Industries, (5) Public Sector Undertakings, (6) Manufacturers of Tobacco Products etc. are, therefore, requested to send nominations of two of their members whom they consider eligible for selection in the committee with the details in the enclosed proforma. The members proposed for selection should be manufacturers of excisable commodities. The nomination form should be filled in triplicate with the necessary particulars and should reach Shri Ashir Tyagi, Additional Commissioner (Tech), Central Excise & Customs, Vadodara-390 007 on or before 20.04.2010 in the prescribed proforma enclosed.

All Trade Associations/Chambers of Commerce and present Members of Regional Advisory Committee are requested to publicize the contents of this Trade Notice among their Members/Constituents and send the nominations before the due date mentioned above.
