

ANNEXURE-A

The Terms & Conditions of the Auction Notice dated 13.11.2013, revised and extended to 28.11.2013, are as under :

1. Interested parties are requested to quote their rate in figure as well as in words.
2. All bidders must enclose their VAT registration Certificate along with tender documents.
3. Tenders filled in pencil, overwriting, illegible or erased will not be considered.
4. Each page of the bid/tender document should be signed by the bidder(s).
5. Incomplete or un-signed quotations are liable to be rejected.
6. 'Quantity(Nos)' mentioned in the Table of Auction Notice dated 13.11.2013, published on 14.11.2013, may increase.
7. Tender must be sealed and accompanied with an earnest money of **Rs.5000/-** (Rupees Five Thousands Only) in the form of **Demand Draft in favour of the Pay & Accounts Officer**, Central Excise, Customs & Service Tax, Vadodara-I Commissionerate, 3rd floor, Central Excise, Customs & Service Tax Bhawan, Race Course Circle, Vadodara-7 from any nationalized bank/scheduled bank. The said amount will be adjusted against the amount payable by the successful bids. In respect of others, the Demand Draft will be returned/released without interest after the successful tender takes possession.
8. The highest bidder will have to deposit the quoted amount in the form of challan within 2 (two) days and lift the said items/furnitures/office equipments within 7 (seven) days from the date of issuing letter of allotment of tender from this office at his/her own cost.
9. Tenders will be opened on 29.11.2013 at 15.30 Hrs. The interested bidder or his/her authorized representative can participate in it. In case 29.11.2013 is a closed holiday, the tender shall be opened on following working day at the same time and venue.


