Subject: Carrying out AGT in CCAs under CBEC in view of upcoming GST - Regarding.

Enclosed please find herewith a copy of D.O F. No. 10A60/23/2017-Ad.IIB dated 16.05.2017 received from Member (Admin), Central Board of Excise & Customs, New Delhi for information and necessary action please.

Under the GST Regime, the following GST Commissionerates are being formed:-

- (1) Vadodara-I
- (2) Vadodara-II
- (3) Vadodara (Audit)
- (4) Vadodara (Appeals)
- (5) Surat
- (6) Surat (Audit)
- (7) Surat (Appeals)
- (8) Daman

Accordingly, representations are invited from Group B & Group C officers for their transfer postings for 2017-2018.

For this financial year 2017-18, keeping in view that orders are required to be issued before 31.05.2017, the following parameters will be guiding principle:-

- (1) Existing transfer policy

- (2) Minimum dislocation
- (3) Request transfer without TTA at own cost
- (4) First in first out principal, in case of more than one candidate
- (5) Functional requirement

Officers may indicate their three stations in order of choice. The office of Chief Commissioner will allot the Commissionerate and further posting within the jurisdiction of Commissionerate will be done by the Commissioner, as per the standard practice of screening by Committees.

Hence, all Group B (Gazetted / Non Gazetted) and Group C may send their representation directly to both Commissioner and Chief Commissioner in the following format:


