TRADE NOTICE No.03/2018

Kind attention is invited to Board's Circular No.39/13/2018-GST dates 03.04.2018 issued under F.No.267/7/2017-Cx.8 regarding Setting up of an IT Grievance Redressal Mechanism to address the grievances of taxpayers due to technical glitches on GST Portal. Further, the Board has issued a letter dated 04.04.2018 issued under same file, copy is enclosed herewith for ready reference.

2. In GST and Central Excise, Vadodara-I Commissionerate, in view of the aforesaid Circular & letter following officers have been designed as the Nodal Officers/Additional Nodal Officer to address the problems of taxpayers due to technical glitches and to receive applications from the tax payers in this regards, if any, in common portal. The details is as under:-

Sr. No.	Name & designation of Nodal Officer	Purpose
1	Commissioner.	An appropriate authority to make/receive further communications with the GSTN which will ultimately reach to the IT Grievance Redressal Committee & to address the problems of taxpayers due to technical glitches
2	Shri Mahesh Kumar Sharma, Assistant Commissioner.	The Nodal Officer to receive applications from the tax payers in this regard.

3. The taxpayers shall make an application to the field officers or the above mentioned nodal officers in case of demonstrable technical glitch of identified issue, due to which the due process as envisaged in law could not be completed on the Common Portal. Such applications shall have enclosed evidence as may be need to establish bonafide attempt on the part of the taxpayers to comply with due process of law.
