Subject: Estt: Grant of Temporary Status and
Regularisation of Casual Workers: 1994

In terms of Ministry of Personnel, Public Grievances and Pensions, New Delhi's O.M. No.51016/2/90-Estt.(C) dated the 10th September, 1993, the undermentioned Casual Workers working in Central Excise and Customs Collectorate, Vadodara are hereby conferred upon temporary status with effect from 1.9.1993 on the following terms and conditions:

1. Conferment of temporary status on a Casual Labourer would not involve any change in his/her duties and responsibilities. The engagement will be on daily rates of pay on need basis. He may be deployed anywhere within the recruiting unit/territorial circle on the basis of availability of work.

2. Such Casual Labourers who acquire temporary status will not however, be brought on to the permanent establishment unless they are selected through regular selection process for Group'D' posts.

3. Temporary status would entitle the Casual Labourers to the following benefits :-

(i) This conferment is without reference to the creation/availability of regular Group 'D' posts.

(ii) Wages at daily rates with reference to the minimum of the pay scale for a corresponding regular Group 'D' official including D.A., H.R.A. and C.C.A.

(iii) Benefits of increments at the same rate as applicable to a Group 'D' employee would be taken into account for calculating pro-rate wages for every one year of service, subject to performance of duty for at least 206 days in the year from the date of conferment of temporary status.

(iv) Leave entitlement will be on a pro-rate basis at the rate of one day for every 10 days of work, casual or any other kind of leave, except maternity leave, will not be admissible. They will also be allowed to carry forward the leave at their credit on their regularisation. They will not be entitled to benefits of encashment of leave on termination of service for any reason or on their quitting service.

(v) Maternity leave to lady casual labourers as admissible to regular Group 'D' employees will be allowed.

(vi) 50% of the service rendered under temporary status would be counted for the purpose of retirement benefits after their regularisation.

(vii) After rendering three years' continuous service after conferment of temporary status, the casual labourers will be treated on par with temporary Group 'D' employees for the purpose of contribution to the General Provident Fund, and will also further be eligible for the grant of Festival Advance/Flood Advance on the same conditions as are applicable to temporary Group 'D' employees provided they furnish two sureties from permanent Govt. servants of their department.

(viii) Until they are regularised, they would be entitled to productivity linked Bonus/Ad-hoc bonus only at the rates as applicable to casual labourers.

4. No benefits other than those specified above will be admissible to casual labourers with temporary status.

5. Despite conferment of temporary status, the service of a casual labourer may be dispensed with by giving a notice one month in writing. A casual labourer with temporary status can also quit service by giving a written notice of one month. The wages for the notice period will be payable only for the work on which such casual worker is engaged on work.

If any of the casual worker is working on part-time basis i.e. less than 8 Hrs. a day, he/she will not be entitled to these benefits. Name of such casual workers may be reported to this office immediately.




